Gift of Hand Bells - Brad updated council that bells were presented to Christ Church from the Queen. They were given to the congregation on Sunday by the Chief. 3.2 Faith Formation	<p>a. Natural Church Development: Brad reported that another church has been asked to participate in the NCD survey. We will not be taking part at this time but hopefully if another round becomes available we can partake.</p> <p>b. Feedback on Instructed Eucharist: It is felt that when a “special Sunday” arises explanation is appreciated and useful. 3.3 Stewardship	<p>a. Treasurer’s Report. The report was reviewed and accepted as is. Explanations were given in regards to fund raising and memorial lines, as well as the \$40,300.00 in the “other expenditures” line (capital transfer to a GIC).</p> <p>b. Furnace Contract – Bill reported that ESSO will discount \$0.10 off the daily price. Each company that offered a service plan said they would need to check the furnace first, each company offered approx the same price of \$239.00 (ESSO) per furnace for one year of insurance.</p> <p>c. Capital Improvements – It is still being determined what has been done at C.C. Information/quotes are still being determined for the roof at All Saints’.</p> <p>d. Fund Raising Policy- Brad presented a new fund raising policy created by the wardens to create guidelines with regards to fund raising. Accepted as presented.</p> <p>e. Results of Walk-A-Thon presented by Marilyn.</p> <p>f. C.C. Fire Inspection – Doug had a fire inspection completed by Chief Scott Maracle. The chief listed that we are deficient in several areas: i) Fire extinguisher out of date; ii) Additional fire extinguishers needed at back entrance and furnace area; iii) CO2 detectors/smoke detectors should be installed in furnace area; iv) Kitchenette exit – table is fire exit restriction, if we moved the pew it would eliminate the issue; v) Exit sign</p>	<p>Doug: ask Lasher Fuels for a price on oil & service.</p> <p>Bill: check with Band Office to see if there is a report of the work done to date at Christ Church.</p> <p>Doug: ask MFD to check our fire extinguishers.</p> <p>We will purchase new fire extinguishers as needed. We also need an inspection routine. Smoke detector and CO2 will be purchased and installed.</p>
